NOTICE OF RACE

1. RULES

1.1 The regatta will be governed by the 2009-2012 Racing Rules of Sailing (RRS), the Sailing Instructions, the prescriptions of the US SAILING Assoc., the Class Rules of the Club 420 fleet, the Perry Series Standing Rules as published in the 2009 SCYYRA year book.

2. ELIGIBILITY & ENTRIES

2.1 Each participant shall be under 21 years of age for the entirety of the series.

2.2 An entry for the regatta must also be completed in accordance with the Notice of Race with an entry fee of \$40.00 by March 10th or \$50 after March 10th. Eligible boats may enter by completing registration at Coronado Yacht Club before 10 AM on March 13th.

2.3 Entries for the 2009-2010 Perry Series are closed.

3. NOTICES TO COMPETITORS

3.1 Notices to competitors will be posted on the official Notice Board located on the front deck of CYC near the Flag Pole.

4. CHANGES TO THE SAILING INSTRUCTIONS

4.1 Any changes to the Sailing Instructions will be posted before 10:15 hours on the day it will take effect.

5. SIGNALS MADE ASHORE

5.1 Signals made ashore will be displayed on the Flag Pole on the CYC Front Deck.

5.2 If for any reason the Race Committee determines that racing should be postponed before leaving the harbor area, code flag AP will be flown. Upon lowering AP, one horn blast will be made and a courtesy departure horn will sound just before the RC Boat departs for race course
